APPLICATION FOR LICENCE TO HARM THREATENED SPECIES, POPULATIONS, ECOLOGICAL COMMUNITIES OR TO DAMAGE THEIR HABITATS

I refer to your application for a licence to harm threatened species, populations or ecological communities, and/or damage their habitats under section 91 of the *Threatened Species Conservation Act 1995* (TSC Act) by trimming dead or dying palm fronds from two large palm trees over critical habitat, received by the Office of Environment and Heritage (OEH) on 10 December 2013.

I have considered the application and supporting information provided. I am satisfied that the impact of the activities as described in your application will be trivial, and as a result I dispense with the need for a species impact statement, in accordance with section 111(4) of the TSC Act. Furthermore I consider that the proposed action is not likely to significantly affect threatened species, populations or ecological communities, or their habitats. Therefore, a licence is not required under the TSC Act for the proposed action.

A certificate to this effect has been issued (enclosed) under section 95 of the TSC Act subject to the conditions prescribed in the certificate.

You should note that it is an offence under section 133(4) of the *National Parks and Wildlife Act* 1974 to contravene or fail to comply with any condition or restriction attached to the certificate.



DESCRIPTION OF PROPOSED ACTION

The proposed action:

- A. Access critical habitat area B to trim dead and dying palm fronds from two large palm trees at the rear of the second of the
- B. Remove trimmed palm fronds from critical habitat area B.

RELEVANT CONDITIONS

The holder of the certificate must ensure that:

- 1. The works are to be carried out in accordance with your licence application signed 10 December 2013.
- 2. The works are to be carried out only during the months of **March May** of any year (ie. outside of Little Penguin breeding season).
- 3. All palm fronds are to be promptly removed from critical habitat after they are trimmed.
- 4. No vegetation other than the trimmed palm fronds is to be harmed, cut, trimmed, altered or removed from critical habitat.

I certify that the activities described in the application dated 10 December 2013, have been determined under Section 94(2) of the *Threatened Species Conservation Act 1995* as unlikely to significantly affect threatened species, populations, ecological communities or their habitats. Consequently the proposal does not require a licence under the *Threatened Species Conservation Act, 1995* pursuant to Section 95(2).
