### **A detailed description of the purpose and benefits of the travel to the State of New South Wales**

During my first visit to Lord Howe Island as Minister responsible for the *Lord Howe Island Act 1953*, I met with a wide range of community and business groups and members of the Lord Howe Island Board. In doing so, I was able to assess progress on key governance, financial, environmental and community amenity issues of concern to Islanders.

Meetings were held with Lord Howe Island Board members and staff to discuss progress on issues including:

- major projects
- infrastructure projects
- planning and land administration issues
- rodent eradication program
- weed program
- cultural and natural history issues
- environmental issues
- world heritage and permanent park preserve
- tourism issues.

I met with two key stakeholders in the tourism industry: Lord Howe Island Environmental Tours and the Lord Howe Island Tourism Association. During these meetings we discussed their concerns and opportunities to develop tourism on the Island.

I also met extensively with the Lord Howe Island Board and discussed a number of major projects that have the potential to have a significant impact on the Island's environment and amenity. These

projects include the implementation of a renewable energy scheme designed to reduce the Island's dependence on diesel fuel, and a rodent eradication program.

I was also delighted to attend an 'Open house' at the community hall where I met members of the Lord Howe Island community including key stakeholders. I was particularly interested in the issues raised at this forum, including: the proposed method of rodent eradication, progress with the renewable energy program and the newly upgraded airport runway, and land allocation matters.
