



Application for a Biodiversity Conservation Licence under the *Biodiversity Conservation Act 2016* to buy, sell, possess, import into or export from New South Wales the carcasses and skins of protected animals (kangaroos and wallaroos) for commercial purposes.

As outlined in the [NSW Commercial Kangaroo Harvest Management Plan 2017-2021](#), only four species of species can be harvested and processed in NSW: Eastern Grey (*Macropus giganteus*); Western Grey (*Macropus fuliginosus*); Red (*Macropus rufus*); Wallaroo (*Macropus robustus*).

Note: Animal Dealer (Kangaroo) Licence applicants require processing facilities approved and authorised by the relevant state or territory food authority.
