### Site summary

Integrated weed control works in the Katoomba Falls catchment, both directly on weeds impacting on habitat areas and on propagule sources within the catchment, are progressively reducing the risks from weed invasion. Some plants show partial dieback, possibly a result of the weeds and/or the heavy water flows. High community engagement has been achieved.

## Management site 2: Narrow Neck

Plants all looking healthy. No weed work carried out in 2015/16 as weeds are not a major issue.

Plants are all healthy and in good condition with few threats.
