Ms Morris knew a former owner and the place during that ownership, but has nothing to do with the current owner. The Committee agreed there was no conflict and no further action was required.

## Item 2. SHR Nominations – Notice of Intention

### Item 2.1 Nowland's Lochnivar Coach Station - NOI

The State Heritage Register Committee noted the presentation on Nowland's Lochnivar Coach Station – NOI by Alexandra Simpson.

## Key points noted:

- o The item has been maintained by the owners with few changes made to its original condition.
- The listing is to include all lots associated with the house when it operated as a coach house.
- o Local council has deemed two lots unsuitable for development due to fire and flood hazards.
- It is anticipated that further local historical knowledge will come to light during the Notice of Intention process.
- The Committee sought further investigations be undertaken to address Aboriginal history and people that have worked on the property or been involved in the local conflicts in the 1930s, as well as comparative information on coach inns and archaeological potential.

# Item 4.1 Anambah House SHR 00275 Curtilage Revision

The State Heritage Register Committee noted the update on Anambah House Curtilage Revision by Judith Coombes.

## Key points noted:

- o Anambah House was listed on the State Heritage Register in 1999.
- The owners have requested a curtilage revision due to subdivision plans. The owners would like to list the entire property excluding most of the driveway.
- A planning proposal for the current driveway to become a street is currently with local council. An
  access road will be created for the neighbouring property and a service access drive will be
  included at the rear of the house.
- The proposed listing extension has allowed for a review of the assessment of significance for the item. HNSW considers that the item is likely to meet four of the seven listing criteria.

The Chair thanked David Hoffman for his work on this item and Judith Coombes for her presentation.

In accordance with section 33(1)(b) and section 33(1)(c) of the Heritage Act 1977, within 14 days after notice of intention to consider listing is given, will cause a notice of intention to consider listing to be published in a newspaper circulating in the area in which the item is situated, inviting submissions on the listing, specifying a date as the closing date for the receipt of submissions of 21 days after the publication of the newspaper notice and the manner in which submissions may be made.

HNSW is currently examining existing heritage agreements and how are they being used, and further work will include a review of heritage agreements from other jurisdictions, to determine best practice. Based on its research, HNSW will present an evidence-based scoping paper at a mid-year Heritage Council meeting, to which SHRC members will be invited.

#### The Committee discussed:

- o The comparison between heritage agreements and site-specific exemptions
- How to uphold a heritage agreement especially when an entity ceases to exist

- Differences between conservation and heritage agreements
- Historical examples of heritage agreements.
- Lisa Trueman offered her assistance to HNSW with regard to heritage agreements.
