



Advanced Class Native Animal Keeper Licence

Application for a biodiversity conservation licence under Part 2 of the
Biodiversity Conservation Act 2016 to keep native animals as pets

Making an Application

Persons wishing to keep native animals listed as 'advanced' class (birds class B2 and B3; reptile classes R2, R3, R4 and R5; and amphibian class A2) on the [NSW Native Animal Keepers' Species List](#) need to obtain an advanced class native animal keeper's licence.

Follow these steps:

1. On page two, tick the box for the class(es) of licence you wish to apply for. You can apply for more than one advanced class at a time
2. Follow the column down and circle the fee for each class you wish to apply for. Add up the fee amount for each class. This will be the total amount you need to pay
3. Read the NOTES and complete the rest of the application form
4. Email the completed form to wildlife.licensing@environment.nsw.gov.au or post it to: Wildlife Team, PO Box 1967, Hurstville NSW 1481. Applications cannot be lodged in person at the Hurstville office or online.
5. Payment can ONLY be made by Credit Card, Cheque or Money Order (made payable to Office of Environment and Heritage)

- An applicant must be over the age of 18 years of age to apply for any advanced class licence.
- An applicant must demonstrate they meet certain criteria before being granted an advanced class, or to apply for a higher category of licence (if applicable).
- If you believe you are eligible for a pensioner discount, you must provide details of your pension card.
- If you have credit remaining from your class 1 licence and are successful in your class 2 application, that remaining credit may be used towards payment of the class 2 licence.
- Lodging an application does not guarantee approval of an advanced class licence. You will be contacted if further information is required to complete the assessment.
- Please allow sufficient time for your application to be assessed. It is recommended that you do not pay deposits to 'hold' animals while your application is being assessed. OEH is not responsible for losses incurred prior to the approval of an upgrade application.
- This application form contains information that identifies you and is defined as "personal information" under the NSW Privacy and Personal Information Act 1998 (PPIP Act). OEH collects and manages the personal information you provide in accordance with the PPIP Act. OEH will not use personal information except for purposes listed as exemptions in the PPIP Act.
- Information supplied on this form will be used by officers of OEH to assess your application. Information collected by OEH may be disclosed to third parties for the purposes of confirming information provided by you in this application, and for law enforcement purposes. Personal information collected by OEH will be stored securely and disposed according to the OEH Records Management Policy. Advanced Reptile Non Venomous, Advanced Bird and Advanced Amphibian

1. Be over the age of 18
2. Have at least 2 years experience in the care and handling of the relevant species of animals (ie, reptiles, birds or amphibians) in a lower class of licence
3. For reptile applications, the reptile being sought must be from the same taxonomic group or family of reptiles that you have had care and handling experience previously (eg if you want to keep geckoes in the advanced reptile class, you must have kept geckoes from the basic class first)
4. Can demonstrate you have kept accurate animal records and complied with the conditions of your licence
5. For Emu Endorsement applications:
 - (a) A minimum area of 1 hectare to be fenced to the standard required for commercial emu farms to contain all emus held under the licence. Please provide an accurate diagram and/or other evidence of your ability to meet enclosure requirements.
 - (b) Stocking rate not to exceed two birds per hectare
 - (c) The enclosure holding the emus must not be used for or include an access to the residential premises, right of way, roadway or include the doorways or any other access to the residential dwelling
 - (d) No person may enter the enclosure without the consent of the licensee
 - (e) The licensee is not permitted to sell eggs, egg shells or any part or product derived from emus
 - (f) The prior consent of OEH is required before the disposal or sale of live emus
 - (g) All activities involving the raising, housing, feeding and transport of emus must conform to the standards outlined in the ['Model Code of Practice for the Welfare of Animals: Husbandry of Captive-Bred Emus'](#) that was developed by the Agriculture Council of Australia and New Zealand

Advanced Reptile Venomous, Category 1, 2 or 3

1. Be over the age of 18
2. Have at least 1 years experience in the care and handling of reptiles in a lower category of licence (you will start off in category 1 before applying to progress to category 2 and so on)
3. House your reptiles in lockable escape proof cages in a lockable room
4. Have and maintain a current first aid certificate. Please provide a copy of your certificate
5. Have and maintain a current "Emergency Response Plan" to deal with snake emergencies. The plan must include how the licensee proposes to deal with an escaped snake, a snake bite emergency, what first aid equipment is available for the treatment of snake bite, the location of first aid snake bite equipment, location and directions to nearest emergency centre, emergency contact details for ambulance and local emergency hospital as a minimum and the contact details of an experienced reptile handler nearby. The plan must be placed in a readily available place such as on the door of the reptile room
6. Only people with the same category and level of licence should have access to the reptile keeping area
7. Submit two signed written references from appropriately qualified people who can attest to your ability, knowledge, experience and suitability to possess the reptile you want to keep. Referees should have extensive experience in the handling and/or husbandry of the species proposed to be held and hold the same or a higher class and category of Native Animal Keeper Licence that you are applying for
8. Can demonstrate you have kept accurate animal records and complied with the conditions of your licence
