Consistent with the purpose of collection, the Department may disclose your personal information to the following third parties: the NSW Food Authority to confirm the authorisation of vehicles and premises used to transport and store kangaroo carcasses, and other states or territories and the Commonwealth for compliance or investigation purposes. Your personal information may also be disclosed to a third party under an exemption under privacy law, including in circumstances where disclosure is required for a law enforcement purpose or as part of the investigation functions of an agency.
