## Submission for the Biodiversity Review:

## To whom it may concern;

I am concerned about the proposed review of biodiversity legislation.

There needs to be better logic applied to these pieces of legislation which seemed to have been applied as a blanket measure to stop land clearing. For example the understanding by farmers that one must not disturb a paddock of native grasses is ridiculous. Maybe this was misunderstood but i know of several farmers who thought this was ridiculous and chose to simply ignore it.

There is also the example of farmers believing that they cannot clear invasive woody species. Whether they may have been allowed or not is not the point.
