Nature Near Me is a free mobile phone app developed and offered for public use by the Office of Environment and Heritage (OEH)

Accuracy of information

Nature Near Me enables you to share information about your favourite nature places. We are keen for you to upload new sites and to share your feedback, ideas and comments with Nature Near Me. In uploading a site or content to the Nature Near Me site you agree to represent to us that all information provided to us is true, accurate and correct. OEH reserves the right to decline to publish a site should we be concerned about the truth or accuracy of the information provided.

Sensitive sites

All sites and comments entered into Nature Near Me are subject to review prior to release to identify if any sensitive sites have been identified. If your post is considered to contain potentially sensitive cultural or natural heritage information we will inform you that we are referring the site to OEH experts for review.

Appropriateness of content

OEH will also decline to publish any third party advertising, commercial sites, spam or posts that contain profanity, defamatory, discriminatory, intimidation, bullying of other users, racist, offensive, obscene or inflammatory content.

Content deemed to have breached local laws will also be removed at the discretion of OEH.

OEH reserves the right to refuse to publish, edit, remove or delete inappropriate posts that do not follow the above guidelines.

Guarantee of service

The Nature Near Me site will be monitored between 9 am and 5 pm seven days a week. We offer a guarantee of service that your site or comments will be published to Nature Near Me within two days. If your post is considered to contain potentially sensitive cultural or natural heritage information we will inform you that we are referring the site to OEH experts for review.
