RE: Section 95 certificate to remove a single tree in the Pittwater Spotted Gum Forest endangered ecological community at 59 Herbert Ave Newport

Thank you for contacting the Department of Environment, Climate Change and Water (DECCW) with your application, pursuant to Section 91of the *Threatened Species Conservation Act* 1995 (TSC Act), for a licence to remove a Spotted Gum *Corymbia maculata* tree at 59 Herbert Ave Newport which was received by the Department on 26-May-2010 . The tree is part of the Pittwater Spotted Gum Forest endangered ecological community and may constitute habitat for the Powerful Owl *Ninox strenua*, which is a threatened species protected under the *National Parks and Wildlife Act 1974*.

DECCW understands that Pittwater Council has issued a permit for removal of the tree, subject to conditions, and that this permit is also subject to the measures described at item 17 of your licence application for minimisation or compensation for harm or damage to the endangered ecological community.

I am satisfied that the impact of the action as described above and carried out in accordance with those conditions is unlikely to have a significant impact on any threatened species, endangered populations or endangered ecological communities or their habitat. The TSC Act makes provision for the issue of a certificate under section 95(2) for actions which technically constitute pick or harm to a threatened species or damage to its habitat, but which are unlikely to have a significant impact. Accordingly, I have decided to authorise your activities and issue you with such a certificate.
