RE: Variation of Section 95 Certificate to remove four *Persoonia bargoensis plants* and 1.8 ha of Shale Sandstone Transitional Forest

I refer to your Section 91 licence application received by the Department of Environment, Climate Change and Water (DECCW) on 02-Jun-2010 for construction of a stormwater pipeline requiring the removal of four *Persoonia bargoensis* plants and the clearing of approximately 1.8 ha of Shale Sandstone Transition Forest regrowth listed as an endangered ecological community.

A Section 95 certificate (No: 1102338) was issued to Tahmoor Coal Pty Ltd for this project on 19 June 2009. However the DECCW understands that the project was delayed unavoidably and the certificate has expired. DECCW has decided to vary the certificate by extending the expiry date for one year

I have assessed your licence application in accordance with the provisions of the *Threatened Species Conservation Act* 1995 (TSC Act) and concluded that the proposal is unlikely to have a significant impact on threatened species, endangered populations or endangered ecological communities. The TSC Act makes provision for the issue of a certificate under section 95(2) for actions which technically constitute damage to the habitat of threatened species, but which are unlikely to have a significant impact. Accordingly, I have decided to authorise your activities and issue you with a Section 95(2) certificate.
