

I certify that the 'picking' of the critically endangered ecological community Blue Gum High Forest and damage to its habitat through direct herbicide application or hand picking of weed species by suitably qualified and experienced bushland regenerators, in the 'restricted' areas as marked on the attached map, for the purposes of weed control at 35 Water St Wahroonga, 64 Billyard Ave Wahroonga and lot 2 DP 375262, is unlikely to significantly affect threatened species, populations, ecological communities or their habitats and consequently the proposal does not require a licence under the *Threatened Species Conservation Act*, 1995 pursuant to Section 95(2).

Please supply Ms Sarah Burke with a brief report of maintenance works including photographic evidence to demonstrate that the actions stated in the Section 91 application have been adhered with. The report should be supplied each three months from the date of this certificate.

This certificate is a defence against prosecution under sections 118A-D of the National Parks and Wildlife Act 1974.

## Re: application for section 91 licence for 35 Water St Wahroonga

I refer to your application, under section 91 of the *NSW Threatened Species Conservation Act* 1995, dated 28 February 2008, to remove debris, noxious weeds and exotic species at the site known as the Waterbrook site (which includes 35 Water St, 4 Billyard Ave and Lot 2 DP 375262).

The Department of Environment and Climate Change (DECC) understands that you have made the licence application as the proposed works may impact on remnants of Blue Gum High Forest (BGHF), which has been mapped by Dr Peter Smith as occurring on site. The DECC understands that you are proposing to undertake selective weed removal in areas identified by Dr Smith as BGHF, and undertake mowing, slashing and mulching in areas outside these identified BGHF areas.

The DECC notes that in the interval since Dr Smith mapped the site, the growing conditions will have been favourable for native species as well as exotics. Therefore, some natural regeneration of BGHF in areas previously identified as not containing BGHF may have occurred. To ensure that the weed control works will not impact on any existing or regenerating BGHF, the DECC has determined that the following actions may occur:

- restricted areas: in the area of mapped BGHF and all adjacent areas (ie areas marked on your map as 883 SQM, 690SQM, 633 SQM and 306 SQM and the 286 SQM area along the south-western boundary of the site) you may use the following weed control methods for exotic species: hand removal (taking care to minimise soil disturbance) or direct herbicide application (eg cut and paint, scrape and paint, tree injection, frilling or chipping, stem swiping). No spraying, mulching, slashing or mowing is to occur in these areas. Works in the restricted areas must be undertaken by a suitably qualified and experienced bushland regeneration contractor.
- unrestricted areas: in the areas that are not adjacent to BGHF areas (ie areas marked on your map as 209SQM, 534 SQM, 332 SQM, 473 SQM, 113 SQM and 300 SQM) you may undertake any actions required for weed control, ie mowing, slashing, mulching or cut and paint methods, provided these works have no impact on the identified restricted areas.

A map is attached to confirm the location of these restricted and unrestricted areas.

The DECC considers that the modified proposal, as described above, is unlikely to have a significant impact on threatened species, populations or ecological communities. The TSC Act makes provision for the issue of a certificate under section 95(2) for actions which technically constitute damage to the habitat of threatened species, but which are unlikely to have a significant impact. Accordingly, I have decided to authorise your activities and issue you with a Section 95(2) certificate (attached).

Given that any works undertaken on site are likely to generate a great deal of local interest, the DECC requests that the bush regeneration contractor contact the DECC prior to commencing weed control works on site. A brief report must also be sent to the DECC every quarter after commencement of works, describing the nature and extent of the weed control works. In addition, the DECC recommends that you also hire an additional independent, suitably qualified and experienced bushland regenerator who would observe the works in progress and liaise with the community if any issues arise.
