**Note:** A licence may not be issued to a private person, or to a non-educational facility, to possess a specimen of a bird of prey or a threatened species, unless the applicant can demonstrate there is a legitimate and worthwhile scientific or educational justification for possessing the specimen.

All applicants must complete Parts 1 and 5 and either Part 2 or Part 3 of the form.
