# Introduction

The 2025 annual compliance report, *Ecological thinning trial in NSW river red gum forests (EPBC 2013/6713)*, shows how the Department of Climate Change, Energy, the Environment and Water has complied with the conditions of approval under the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act) when conducting ecological thinning trials within River Red Gum parks in southern New South Wales.

This report has been prepared for the period 1 July 2024 to 30 June 2025.

Thinning operations were completed in August 2017.
