ENFORCEABLE UNDERTAKING UNDER SECTION 13.27 OF THE *BIODIVERSITY CONSERVATION ACT 2016* (NSW)

1. Person giving the Undertaking

1.1. This undertaking is given to the Department of Climate Change, Energy, the Environment and Water (the Department), by [REDACTED] (the Landholders) for the purposes of section 13.27(1) of the *Biodiversity Conservation Act 2016* (NSW) (BC Act) in connection with a matter in relation to which the Environment Agency Head has a function under the BC Act.

2. Background

2.1. The Landholders own [REDACTED] described as [REDACTED] (the Property).

2.2. The Property is used as the Landholder's principal place of residence. [REDACTED]

2.3. The Property is 10.18 ha in area.

2.4. The Property was purchased by the Landholders on 8 October 2024 for residential purposes and to start a horticulture business.

- 2.5. After the purchase of the Property, the Landholders instructed a contractor to clear and burn 2.48 ha of native vegetation on the Property, to create a clear area to commence horticultural farming practices on the Property (**the Clearing**).
- 2.6. The Clearing was conducted without consultation with the regulatory body, Local Land Services. A stop work order was issued by the Department on 1 November 2024. The Landholders ceased clearing on this date and have complied with the Department's investigation of the matter.
- 2.7. The area cleared constitutes part of the NSW Plant Community Types (PCT 3420) Clarence Lowland Ironbark-Spotted Gum Grassy Forest and (PCT 3561) Clarence Lowland Smudgy Apple-Paperbark Forest. These areas are known habitat for the vulnerable species *Eucalyptus tetrapleura* and *Angophora robur*. The area cleared also included mature protected plants (*Xanthorrhoea* sp.).

3. Details of the alleged contravention

- 3.1. The Department alleges that:
 - a) 2.48 ha of native vegetation was cleared in a regulated rural area (Category 2), without consent or a defence outlined in Part 5A of the *Local Land Services Act* 2013 (**LLS Act**), constituting a breach of section 60N of the LLS Act,
 - b) the clearing may have impacted up to three *Eucalyptus tetrapleura*, constituting a breach of section 2.2(1)(a) of the BC Act,
 - c) up to 20 mature *Xanthorrhoea* sp. were impacted, constituting a breach of section 2.2(1)(c) of the BC Act.
- 3.2. In response to an investigation conducted by the Department in relation to the alleged clearing on the Property, the Landholders:
 - a) acknowledge that it is alleged by the Department that their conduct possibly contravened section 2.2 of the BC Act and section 60N of the LLS Act,
 - b) acknowledge the seriousness of any harm, or potential harm to the environment or community,
 - c) make a positive commitment to cease the conduct.
- 3.3. Since the investigation has begun the Landholders have ceased land management activities and complied with all Department advice.

4. Commencement of this Undertaking

- 4.1. This Undertaking comes into effect when both of the following have occurred:
 - a) this Undertaking is executed by the Landholders; and
 - b) this Undertaking so executed is accepted by the Environment Agency Head of the Department (**Commencement Date**).
- 4.2. This Undertaking is to remain in effect for a period of 25 years from the Commencement Date (**the Term**), unless withdrawn or varied under section 13.27(3) of the BC Act.

5. Undertakings

5.1. For the purposes of section 13.27(1) of the BC Act, the Landholders undertake that they will:

- a) complete revegetation works in the areas outlined as Enforceable Undertaking on the attached map (**Annexure 1**) and complete annual monitoring reports (listed below in section 9), which include photos at assigned Photo Points (marked in **Annexure 2**).
- b) replant site-specific vegetation at a rate of no less than 1000 plants per ha in the cleared areas, with a reasonable mix of species that constitute the plant community type of the Enforceable Undertaking area (**Annexure 3**).
- c) maintain, protect and manage the newly planted vegetation in the Enforceable Undertaking area, ensuring the survival of the new vegetation.
- d) commit to conserving and protecting any standing vegetation in the area marked Enforceable Undertaking on the attached map (**Annexure 1**).
- e) undertake weed control across the Enforceable Undertaking area at 3 monthly intervals for the Term of this Enforceable Undertaking. The Landholders commit to becoming familiar with identifying native species to be conserved and weeds on the Property. Weeds will be defined and controlled in line with the information provided at <https://www.clarence.nsw.gov.au/Environment/Biosecurity/NSW-WeedWise>.
- f) ensure that the following activities are not undertaken within the Enforceable Undertaking area, unless preapproved in writing by the Department, or are part of the works that are the subject of this Enforceable Undertaking:
 - a) Soil disturbance (including cultivation),
 - b) clearing of any native vegetation not designated as a weed species,
 - c) grazing of any non-native animals,
 - d) removal of any fallen timber,
 - e) aerial or boom spraying of weeds, and
 - g) storage of waste or rubbish.
- h) report progress on all tasks in this Undertaking to the Department annually against the monitoring indicators listed below in section 7.1.
- i) provide, at their expense, a copy of any documents reasonably required by the Department in relation to the Undertaking.
- j) agree that the Department will make a publicly available Media Release.
- k) inform any potential purchasers of the Property of this Enforceable Undertaking.

- l) inform the Department if the Landholders intend to sell the Property by email to admin-northeast@dcceew.nsw.gov.au. Marked to the attention of "Compliance and Regulation".

6. Requirements for compliance with this Undertaking

- 6.1. The Department will, from time to time, inspect the Property to ensure compliance with the conditions of this Enforceable Undertaking and will take further compliance action where necessary. The Department will provide the Landholders with 7 days' notice prior to inspecting the Property.
- 6.2. The Landholders will provide reasonable access to staff of the Department for the purposes of monitoring and enforcing compliance with this Undertaking which includes providing access to inspect the Enforceable Undertaking area as required.
- 6.3. For clarity, Enforceable Undertaking area refers to the area marked "Enforceable Undertaking" on **Annexure 1**.

Time for compliance

- 6.4. Within four (4) weeks of the Commencement Date, the Landholders will remove all stock (cows, pigs, sheep, chickens, goats etc.) or domestic animals (dogs, cats, etc) from within the Enforceable Undertaking area. Stock or domestic animals are not permitted within the Enforceable Undertaking area for the Term of this Undertaking. If any stock or domestic animals are on the Property, the Landholders must maintain a fence suitable to exclude any stock or domestic animals and ensure stock or domestic animals are unable to access the Enforceable Undertaking area.
- 6.5. Within twelve (12) weeks of the Commencement Date, the Landholders will remove all rubbish, construction materials, weeds, exotic species, non-native plants, and commercial crops from within the Enforceable Undertaking area.
- 6.6. Within eight (8) weeks of the Commencement Date, the Landholders will remove and exclude all invasive fauna species (pigs, goats, deer, etc) from within the Enforceable Undertaking area. The Landholders will effectively manage the removal of invasive fauna species within the Enforceable Undertaking area for the Term of this Undertaking.
- 6.7. Within twelve (12) weeks of the Commencement Date, the Landholders will construct a fence (including access gates if necessary) around the perimeter of the Enforceable Undertaking area marked as Proposed fenceline on **Annexure 1**, to prevent access.
- 6.8. Within eight (8) weeks of the Commencement Date, in perimeter areas of the Enforceable Undertaking area **not** marked as Proposed fenceline on **Annexure 1**, a fence is not required (unless required by section 6.4 above), however the Landholders will install and maintain coloured marker posts (at intervals of no greater than 25 meters) around the perimeter of the Enforceable Undertaking area for the purposes of clearly identifying these areas from other areas of the Property.
- 6.9. No dams, sheds, tracks or other rural infrastructure will be constructed within the Enforceable Undertaking area during the Term of this Undertaking unless pre-approved in writing by the Department.

Cost of compliance

6.10. The Landholders will be responsible for all costs associated with implementing and complying with the conditions of this Undertaking.

7. Monitoring benchmarks

7.1. The Landholders agree that the Department will use these measures to ensure compliance with this Undertaking:

- a) The Landholders will provide annual receipts for all replanting to the Department by 31 August for the first five years of this undertaking, commencing from the first August after this Enforceable Undertaking being accepted.
- b) The Landholders will provide an annual monitoring report to the Department by 31 August of each year for the Term of this Enforceable Undertaking, which includes photos at assigned Photo Points (marked in **Annexure 2**) showing the coverage of replanting, the recovery of vegetation and the maintenance of weeds at the property. Photos will be taken facing North, East, South and West from the photo point marker location every 6 months and included in the annual report.
- c) The Landholders will replant vegetation in the cleared areas of the Enforceable Undertaking area at a rate of no less than 1000 plants per ha, with a reasonable mix of species from the species list in **Annexure 3**. If, during the Term of this Enforceable Undertaking, any planted vegetation dies off or is adversely impacted, the Landholders will continue to replant these species until plant survival is achieved, providing receipts to the Department by 31 August of each year for any vegetation replanted at the Property.
- d) The Landholders will effectively manage the removal of weeds, exotic species, non-native plants, and commercial crops from within the Enforceable Undertaking area for the Term of this Undertaking. Only selective methods (non-mechanised) of poisoning and/or manual removal are to be used. The Landholders will maintain weeds in Enforceable Undertaking area to less than 5% cover of weed infestation per hectare.

8. Annual monitoring report

- 8.1. A Monitoring Report must be submitted to the Department annually during the Term whilst this Undertaking is in force.
- 8.2. The report is due annually on 31 August every year from the Commencement Date. Monitoring Reports must contain the records listed in the below table.
- 8.3. Landholders may either complete all requirements themselves or choose to engage an ecologist or weed specialist or other contractor to conduct works, conduct inspections and complete the Monitoring Report. The monitoring report must be submitted by the Landholders to the Department.

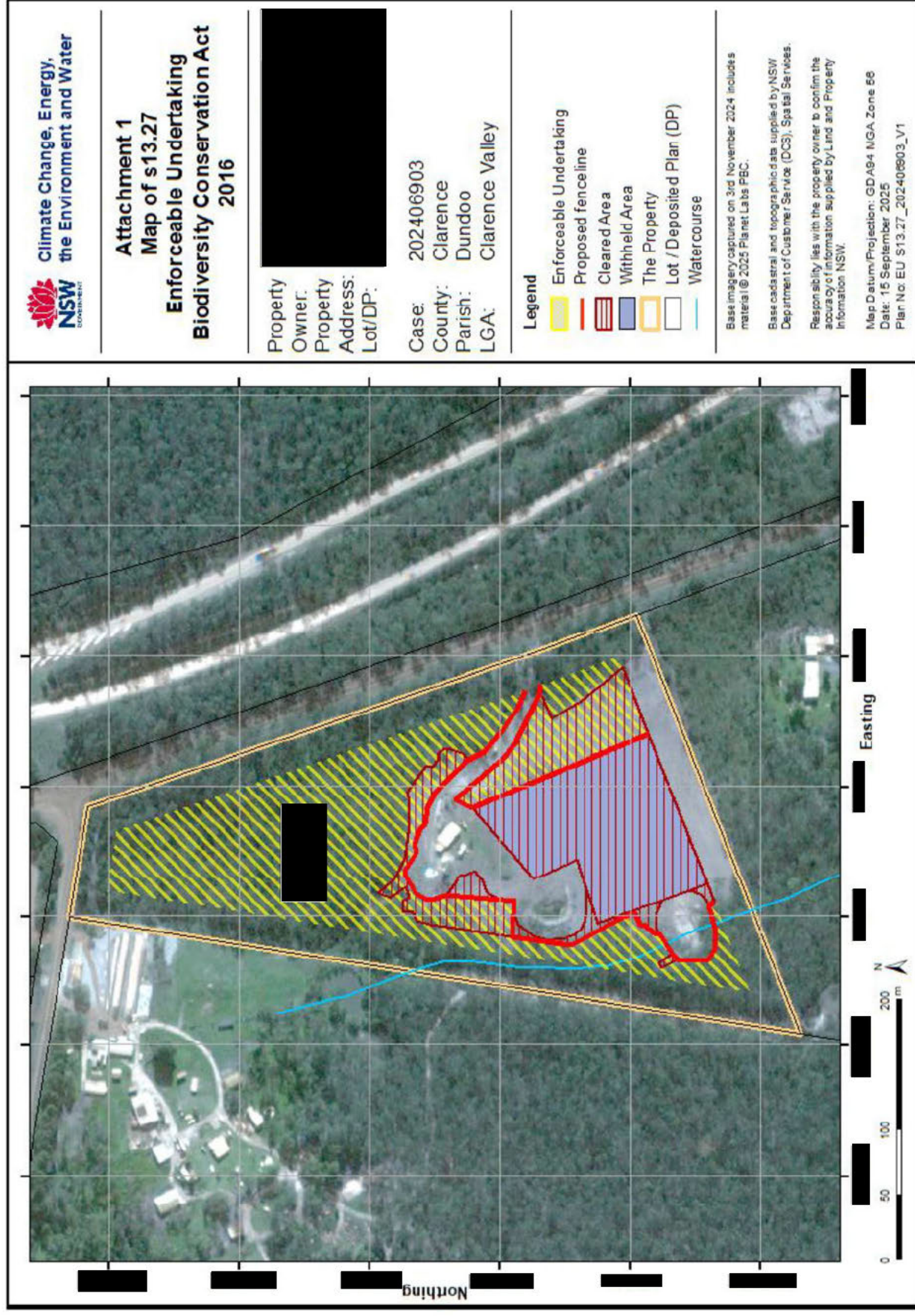

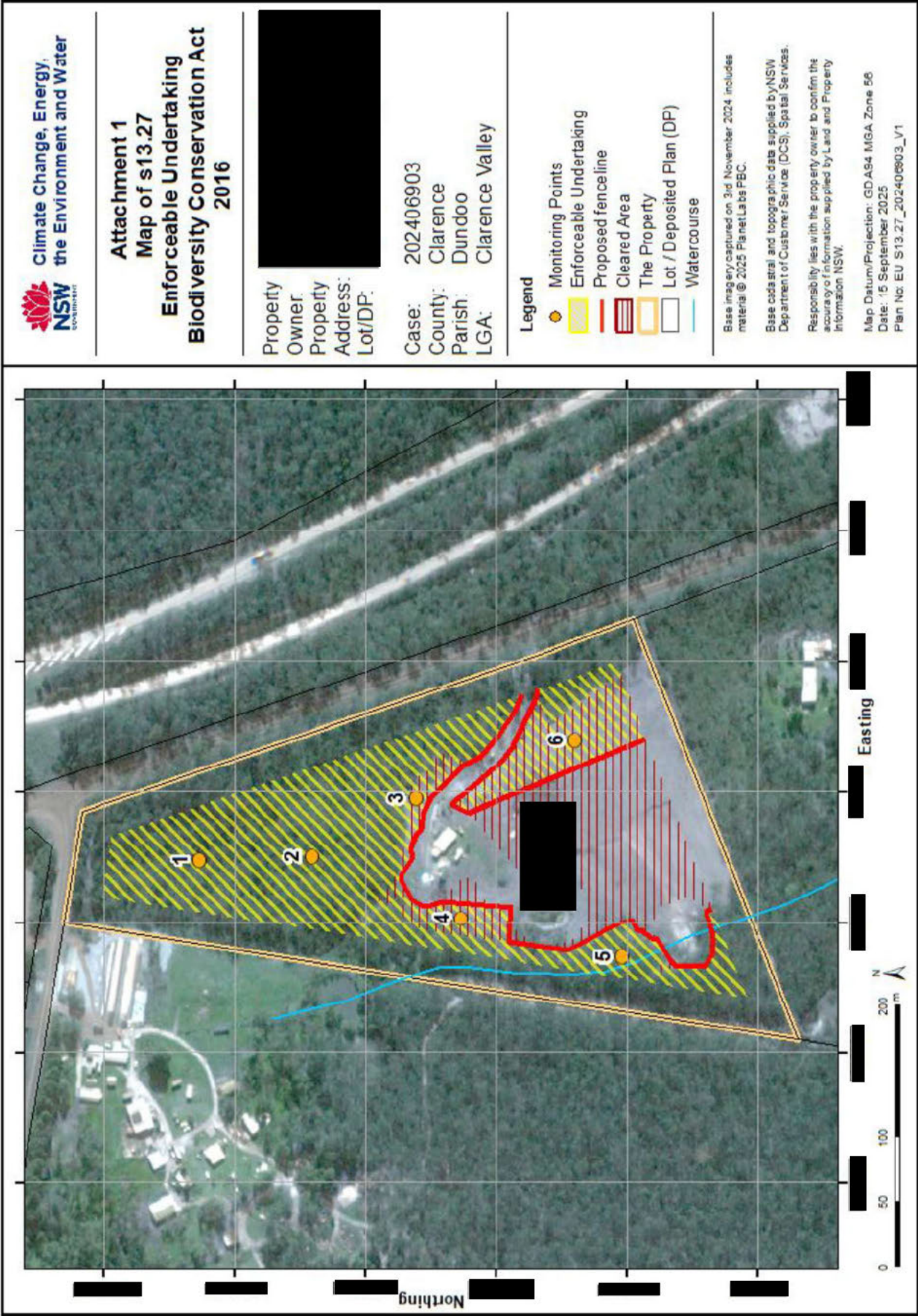
